CALLING FOR

WHEREAS, in accordance with New York State Town Law Article 12-a, the Town Board of the Town of Montgomery, County of Orange, State of New York wishes to establish a new Town of Montgomery Ambulance District in the Town of Montgomery, which district shall include parcels totaling approximately \pm 719 acres that are bounded and described in a Map, Plan and Report dated December, 2020 and most recently revised on December 10, 2021 and prepared by Farr Engineering; and

WHEREAS, the proposed creation of the Town of Montgomery Ambulance District shall provide emergency medical services, including, but not limited to, paramedics and emergency ambulance transportation to all residents located within the Town of Montgomery, County of Orange, State of New York, including the three (3) Villages within the Town – Village of Maybrook, Village of Montgomery and Village of Walden, as such area is further bounded and described in the aforesaid Map, Plan and Report as described and now on file in the office of the Town Clerk of the Town, and

WHEREAS, the services and facilities to be utilized within the proposed district to be, and the cost of the creation of the district, including, any and all staff and facilities associated with providing the general public with emergency medical treatment, assessment and transport, and the entire cost of improvements necessary shall be borne by those properties within said district by way of a tax that will be assessed against each property within the district, and

WHEREAS, the maximum amount proposed to be expended for the district improvements and services associated with said district by the Town and incorporated Villages, as stated in the Map, Plan and Report is \$800,000.00 for FY 2023, and which Map, Plan and Report is now on file and available for review in the Office of the Town Clerk of the Town; and

WHEREAS, the cost to the typical property owner included in this district shall be at the proposed tax rate of \$0.4639 per \$1,000.00 of assessed value of the subject property; and

WHEREAS, the proposed action of establishing an ambulance district is preliminarily classified as an Unlisted Action under the NY State Environmental Quality Review Act, and

with this Order, the Town Board declares its intent to be Lead Agency and directs that notice of same be circulated to the necessary parties; and

ORDERED that on Wednesday the 12th day of January, 2022 at 6:30 o'clock P.M. on said day, the Town Board will meet and hold a public hearing to consider the establishment of the Town of Montgomery Ambulance District, including the environmental significance thereof, and to hear all persons interested in the subject therefore, and for such other and further action on the part of the Town Board in connection with this matter as may be appropriate, and be it

FURTHER ORDERED that the Town Clerk is hereby directed to publish a certified copy of this Order at least once in the official newspaper of the Town not less than 10 nor more than 20 days before the date of the hearing, and be it

FURTHER ORDERED that the Town Clerk is hereby directed to cause a certified copy of this Order to be posted on the sign board of the Town not less than 10 nor more than 20 days before the date of the hearing.
