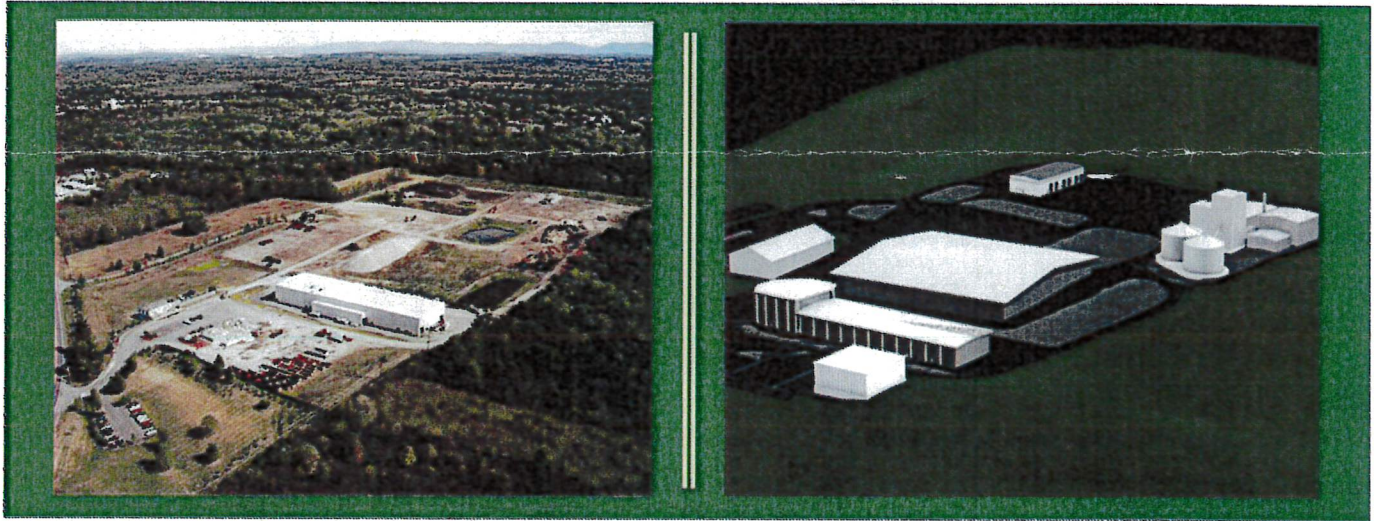

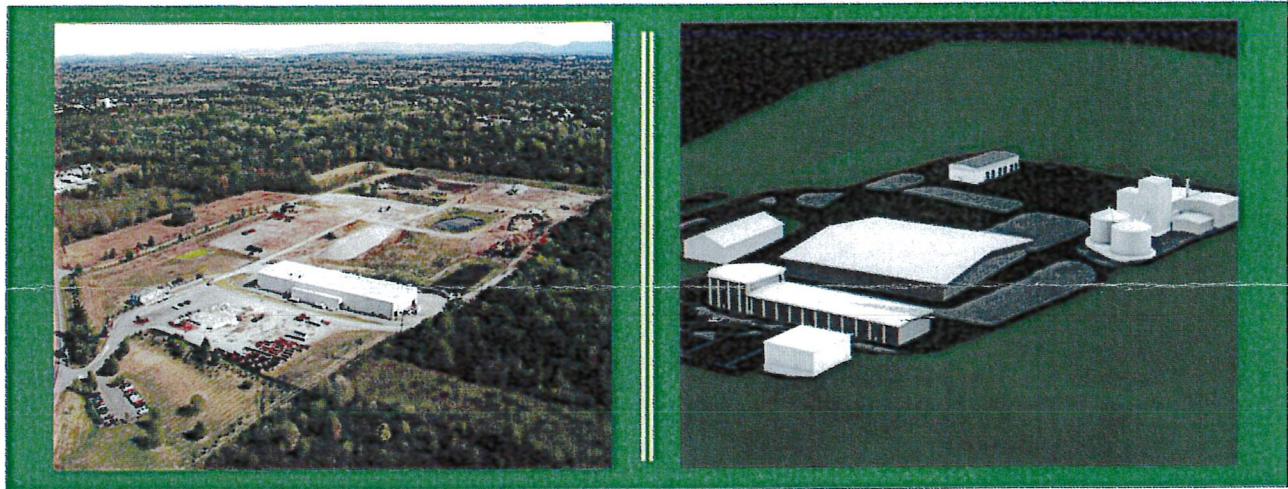

# Taylor Holding Group LTD. Title V Air Permit **Fact Sheet**



## Get your questions answered.

**Taylor Holding Group LTD (Taylor) is applying for a Title V Air Permit from the New York State Department of Environmental Conservation (NYSDEC) for its existing Montgomery Wallboard Processing Plant and proposed Biomass Gasification Facility to be located at the Taylor Construction and Demolition (C&D) Processing Facility at 350 Neelytown Road, Montgomery, NY.**

As part of the application process, Taylor is notifying the public about this permit application and providing an opportunity for comment.

**Why does Taylor need to apply for the permit?** The Facility operates under an existing State Facility Air Permit. However, NYSDEC has asked Taylor to submit an application for a Title V Air Permit covering both the existing wall board processing operation and the proposed gasification facility.

**How might the permit approval affect the surrounding community?** The permit approval will:

- Not result in any change to the existing permitted construction and demolition (C&D) disposal operation.
- Not result in any changes to the proposed gasification facility previously approved by NYSDEC.
- Allow Taylor to convert over 1,000 tons of organic waste into 300 tons of processed biomass per day.
- Allow Taylor to produce about 20 Megawatts (MW) of power annually to the electric grid via existing substations.
