NOTICE OF PUBLIC HEARING**

**PLEASE TAKE NOTICE** that a public hearing will be held by the Town Board of the Town of Montgomery on January 21, 2021 at 6:30 p.m. at Montgomery Town Hall to consider the formation of a Town-wide ambulance district in the interest of public safety for the purpose of providing emergency medical and ambulance services with the Town pursuant to the Order of the Montgomery Town Board Calling For Public Hearing Dated January 7, 2021 bounded and described in accordance with the Map, Plan and Report, dated January 6, 2021 prepared by Farr Engineering, which report is now on file in the office of the Town Clerk of the Town, and

The maximum amount to be expended by the District for such ambulance services in the first year after formation of the District is \$1,000,000.00, which is estimated to be \$0.308 per \$1,000.00 of taxable assessed property value, which is estimated to be \$77.00 to the typical property within the Town of Montgomery.

**NOTICE IS HEREBY ALSO GIVEN** pursuant to Article 8 of the Environmental Conservation Law (State Environmental Quality Review Act/SEQRA) and its implementing regulations contained in NYCRR Part 617 that the Town Board of the Town of Montgomery has determined that the proposed action is classified as Unlisted and that it should act as Lead Agency for purposes of SEQRA review and will be conducting said SEQRA review during the public hearing referenced herein.
