**Description of Project Sailfish:** The project consists of the development of a warehouse distribution center located on 187.7 acres of vacant land bordering on Interstate Route 84 and NYS Routes 17K and 747 in the Town of Montgomery, New York. The warehouse distribution center would consist of a single building containing 1,010,880 square foot of space, 1,060 car parking spaces, 225 truck trailer parking spaces, a wastewater treatment plant for sanitary wastewater, water treatment facility and water tank, stormwater management basins and related improvements, accessory driveways to and from the site, lighting, landscaping, signage, and other related improvements (the "Project"). The Project also includes a requested zoning map amendment from the Town Board of the Town of Montgomery to rezone approximately 77 acres of the project site

from the IB Interchange Business Zoning District to the I-2 Industrial Park – Major Access Zoning District. The Project also requires a special exception use permit ("SEUP") and site plan approval from the Planning Board and an area variance for parking space sizes from the Town of Montgomery Zoning Board of Appeals.
